

FIELD SAFETY TIPS:

1. Please do not linger on the runway when picking up your airplane. It is important that you vacate the runway as quickly as possible as long as its safe to move your airplane.

- 2. <u>Do not park your airplane on the main taxiway</u>, as it makes it difficult for pilots to taxi out to the runway and to taxi back after landing. Many parked planes have been struck on the taxiway. Be smart, park elsewhere.
- 3. When crossing the runway, please make sure that you get an acknowledgement from all active pilots (in the pilots' box) that it is ok to cross the runway. Do not walk diagonally across the runway; always cross perpendicular to the runway for safety.



The PBRCA has been monitoring the lake for hazardous conditions and at this time "LAKE FLYING" is OPEN until further notice.




The membership has approved the proposed rules for flying off 'West Lake'; at our May 9, 2016 membership meeting. The changes and additions are now incorporated into our Safety Rules as Revision K (rev.k).

Palm Beach County has previously established "flying" boundaries and we need to adhere to those restrictions. There is an aerial map showing the boundary lines for west & south flying and it is posted in the bulletin board located at the "impound". Our club has already been warned about flying over the Everglades by a Federal Wildlife Officer. You must fly within the designated boundaries!

SAFETY FIRST!

Save your money for a new plane, battery, servo or radio.

Slow Down & Stay Safe!

Landing Your "Prop" Warbird

Landing is the only mandatory maneuver! A few years ago, Jack Devine wrote a very nice article for RCWarbirds.com about flying prop driven warbirds and I thought it useful to share Jack's piece on landing.

Every flight will end with some type of landing and if you prepare and set it up properly you will have successfully completed another flight. This routine needs to be automatic. Setting up the plane for landing is not difficult but you need to understand again that you are flying a warbird. Warbirds have flaps and if your model has them Use them. Throttle back in straight and level flight and drop your flaps and see what it does to the flight characteristics of your plane. It should immediately start to slow down and if the power level is above half throttle it should start to climb. At low power it will continue to slow down. You manage the decent with the throttle not the elevator. This is important and you need to make sure you understand it.

Now let's set the landing up.

Call your landing so the other pilots on the flight line know your intentions.

Make a straight and level pass in front of you and reduce the throttle to about half and drop the landing gear. Fly another circuit and visually verify your landing gear is down. You should be 100 feet up as you turn onto the downwind leg. Drop your flaps and correct any altitude change. I dial in about 5 degrees of down elevator mix with the flaps through the coupling available in my radio and this keeps the plane flying level. It also gives me a shorter list of things I have to do as the radio automatically takes care of the trim change after dropping the flaps. Turn onto the base leg and you should still be at about 100 feet. Turn final and start your decent as you reduce throttle to about 1/3rd. Point the airplane at the touchdown area at the end of the runway and control the decent with the throttle not the elevator. To steepen the decent, reduce the throttle and to decrease the decent add a little more power. Steer the plane to touchdown with the rudder. Use the ailerons to keep the wings level. The entire approach should be at about a 45-degree angle. This seems pretty steep to some pilots but this is the right method. At about ten feet of altitude, you should be just over the end of the runway and if everything looks good reduce the throttle to idle and at about three feet start your flair. Let the plane settle on the mains and do not force the tail down with up elevator. Use the rudder not the ailerons to keep the plane going straight and as the speed bleeds off the tail will come down on its own and then you can steer with the tail wheel. Forcing the tail down can cause a takeoff and at this airspeed and low power you will certainly stall and we know the result.

If you are not satisfied with the approach simply add power slowly and keep the wings level. As the power comes back up so will the airspeed and the plane will start flying again. Climb slowly and do not attempt to turn until you are sure you have enough airspeed to do it safely. Just remember that if you are going to miss the approach add power slowly. You will want to jamb the throttle wide open and this could cause the dreaded death roll. Don't panic just add power slowly and start a gentle climb out back to your landing setup altitude and try it all over again. Don't force a landing any more than you would force a takeoff.

Once you have your plane back on the ground and you are breathing normally again analyze the entire flight and think about what you could have done to improve it.

FAA REGISTRATION

Effective February 25, 2019, the FAA Interim Final Rule (Part 48) requires ALL unmanned radio controlled aircraft PILOTS flying unmanned aircraft weighing more than 0.55 pounds and up to 55 pounds (airplanes, helicopters, jet turbines, drones, quads, etc.) to register with the FAA and affix their assigned FAA Registration number to the 'EXTERIOR' of EVERY aircraft that they fly.

HOW AMA INSURANCE

WORKS

whether it be positive or negative. If you can see it as a learning experience, you can turn any negative into a positive."

If you are anything like me, you prefer life throwing positive experiences your way. Yet some of my more memorable lessons came from adversity. I'll spare you the details; after all, my therapist gets paid to listen to my madness, but why do I bring this up? I thought this would be a perfect introduction for this month's topic: insurance.

I have written about insurance in the past, but I want to mention again that AMA doesn't determine coverage or adjust claims. AMA contracts with an independent claims adjuster known as a Third-Party Administrator (TPA), who works on behalf of the insurance company to review the specifics of each incident to determine whether coverage is applicable. Your AMA team serves as the initial liaison between you, the AMA member, and the TPA.

Recently, there was some online discussion about AMA's member insurance coverage, its excess status, and how and when it works when other applicable coverage—usually homeowners coverage—is involved.

HOW AMA INSURANCE

Although I can't go into the details of the incident that prompted the debate, I want to use some general information to better explain the insurance coverage provided to you as a membership benefit.

First, AMA's insurance is "excess" to any other applicable insurance coverage. Therefore, if your modeling activities cause property damage or bodily injury, you must submit a claim through any other insurance coverage you have available that would respond to this kind of claim.

So, when does AMA's coverage come into play? If you don't have any other insurance, AMA's coverage would be primary. This would also be if you have other liability insurance, but it doesn't provide coverage for your modeling activities. This is usually determined by a specific exclusion listed in your policy.

Finally, if you are involved in a claim that exceeds the insurance limits of your other applicable coverage, AMA's liability coverage will fill in the gaps.

I like to use examples, so bear with me.

Example 1: Orville Wright is at an event flying his aircraft. His airplane crashes into a truck owned by Charles Lindbergh, causing property damage. One of the following results:

A: Orville submits the claim into his homeowners insurance and that insurance pays the claim.

B: Orville turns the claim into his homeowners insurance, which denies the claim because the policy specifically excludes model aircraft. Orville submits the claim and denial to AMA. The TPA pays the claim.

C: Orville doesn't have any other insurance and submits the claim to AMA. The TPA pays the claim.

Example 2: Orville is at the event and his aircraft crashes into a nearby barn, starting a fire. The fire damages/destroys farm equipment and the barn, causing \$300,000 in property damage.

HOW AMA INSURANCE

A: Orville has homeowners coverage, but only for \$100,000. He submits the claim to his homeowners insurance and to AMA. The homeowners insurance will pay the \$100,000 and AMA's TPA will pay the remaining \$200,000.

Sometimes a homeowner's adjuster might deny a claim because the incident was unexpected or unforeseen. When we encounter such reasoning, we obviously disagree because an accident is rarely an expected or foreseen event.

In these cases, AMA can serve as your advocate and reach out to its resources, including our legal counsel or TPA, to contest the homeowner carrier's denial. However, if the homeowner carrier's adjuster maintains its stance, AMA's TPA's hands are tied based on the policy language, and they cannot pay for the damages.

If I were to talk with Charles Lindbergh, I would tell him that in my 22 years of working for AMA, I have only encountered one claim in which a homeowner's carrier denied liability and then stuck their collective heads in the sand



TIPS a TRICKS

AFFIXING YOUR FAA REGISTRATION NUMBER TO THE EXTERIOR OF YOUR AIRCRAFT

The FAA Temporary Interim Final Rule (Part 48) effective February 25, 2019 does not specify a size or location for affixing your FAA number to the outside of your RC Aircraft.

Custom 'water slide' decals: You can purchase water slide decal paper for your home printer and make custom water slide decals in any size, any color and any font that you want. They can be placed anywhere on the exterior surface of your aircraft.

Permanent Marker: You can purchase permanent markers in a variety of colors and write your FAA & AMA numbers on the exterior of the aircraft. Or write it on clear scotch tape, or packing tape and create a 'removable' label for when you sell the aircraft.

Masking Tape & Marker: You can purchase masking tape in different sizes (width) and create a removable label with a marker pen.

Vinyl Decals: You can purchase custom made press-on vinyl decals in a variety of colors, sizes and fonts (I know a 'guy' at the field)!

The FAA Registration number is registered to YOU, the pilot, and that registration number must be applied on the exterior of <u>ALL of your</u> aircraft.

You can apply the FAA registration number anywhere on the exterior of the aircraft, including the back of the propeller, underside of the wings or elevator, or below the elevator on the fuselage if you don't want it to be prominent.

PS - If you have an FAA Part 107 license (Commercial RC pilots), you must register EACH aircraft separately and put the unique registration number assigned to that aircraft on only that aircraft.





Dear valued AMA member,

When the FAA Reauthorization Act of 2018 was signed into law, it included a requirement for recreational UAS users to pass a knowledge and safety test. The Recreational UAS Safety Test, or TRUST, has the goal of increasing awareness of safety and best practices in the most complex airspace system in the world. AMA has worked closely with the Federal Aviation Administration (FAA), ensuring that TRUST meets the intent of Congress without placing an undue burden on our hobby community. AMA has been there to help make decisions regarding guidelines, administration, and questions included on the test.

Since 1936, the AMA has been dedicated to the hobby of model aviation, educational programming, and safety in the airspace. As such, the FAA selected AMA as a test administrator for TRUST.

What can you expect from TRUST? First, AMA is offering it for free for all recreational fliers. But don't worry, it is more like a brief training session than a test, because you can't fail!

There is some information to read that deals with flying safely and legally, along with 23 multiple-choice questions. If you select an incorrect answer, you'll be guided to the correct response until you get it right. After you finish, you'll receive a TRUST completion certificate that you should print, save electronically, or take a photo of with your phone. This certificate is proof that you passed, and you will only have one opportunity to save it. To protect your privacy, the FAA dictates that taking the test is anonymous and no record is kept by anyone other than you, so losing your certificate means you need to retake the test.

More information about TRUST can be found at www.modelaircraft.org, including frequently asked questions. We're here to ensure that you can quickly pass the test and potentially learn something new as a recreational pilot. We even have a quick tutorial you can look through to get an idea of what you'll need to know.
