

# Conversion to January 1 Payment Proposal

- Beginning January 1, 2026, we are transitioning the club membership period to a calendar year. Club membership will run from January 1<sup>st</sup> through December 31<sup>st</sup> for all members going forward.
- Because some members will have two-year memberships, our transition will span two years (the “Transition Period”) with all members fully transitioned by January 1, 2027.
- During the two-year Transition Period, members will pay an amount based on their original expiration date. Memberships expiring after December 2025 and December 2026 will pay a prorated payment as shown in the schedule below.

# Conversion to January 1 Payment Proposal

- **Active AMA membership is required at time of joining or renewal. AMA expiration date will no longer be linked to club membership expiration date.**
- There will be a 30-day grace period each year beginning January 1<sup>st</sup> to make payments; however, membership will still run from January 1<sup>st</sup> through December 31<sup>st</sup>, regardless of when payment is made, **membership is calendar year**.
- Existing members will not be eligible for prorated payments after the Transition Period, for example, if a member does not renew until March, they would owe the entire \$50, and their membership would still expire December 31<sup>st</sup> of that year.
- Only new members will be eligible for prorated payments (calculated at \$4 per month) in their first year.
- **It remains the responsibility of each pilot to keep their AMA membership current.** The club will send monthly reminders to members about AMA renewals.
- **Club membership cards and AMA cards must be displayed while flying.**
- Member only benefits (password) will be updated each year on February 1<sup>st</sup>, and only members who have renewed by that time will get the new password.
